

NOTICE INVITING TENDER (NIT)

Quotation for Contract for Supply of Medicines at Bank's dispensaries

from April 2023 to March 2024

Consequent to the response of the chemists/druggists/stockists to the advertisement issued by Reserve Bank of India in leading local newspapers on January 20, 2021 for "Empanelment of chemists/druggists/stockists for Supply of Drugs and Medicines to RBI Dispensaries", a panel of six suppliers for the period from April 01, 2021- March 31, 2024 viz Sri Durga Medical Agency, M/s Apollo Pharmacy, Sri Laxmi Medical Hall, Vijaya Medical & General Stores, Sri Mahesh Pharma and Hindustan Medical & Surgicals, who have fulfilled the eligibility criteria and agreed to all the terms and conditions specified in Request for Empanelment document has been prepared.

2. We now invite quotes from empanelled chemists /druggists /stockists for the tender for awarding the Contract for supply of medicines to the Bank's Dispensaries from April 01, 2023 to March 31, 2024. The likely expenditure is Rs. 3.5 crore. If interested, you are requested to quote your best uniform discount rate for the tentative purchase of items as per the list enclosed. Your offer should be made in Price Bid in Part II of this e-tender. An Earnest Money Deposit (EMD) of Rs. 7,00,000/- (Rupees Seven lakh only) has to be deposited on or before February 27, 2023. The price bids of such of the empanelled chemists / druggists/stockists who have submitted EMD would only be considered for award of the Contract.

Terms & Conditions:

Terms and conditions as detailed below as also specified in our Request for Empanelment Document and agreed by you shall apply. Special conditions as indicated in **Form-I** shall also be applicable.

1. Earnest Money Deposit (EMD) of **Rs.7,00,000/- (Rupees Seven lakh only)** must be deposited on or before February 27, 2023 (02:00 PM) along with your bids by way of credit through NEFT (IFSC: RBIS0NEFTHY (please read the fifth letter as ZERO); Beneficiary name: Reserve Bank of India, Hyderabad, A/c No 8614038). **Bids without EMD will not be considered and will be summarily rejected.** EMD of unsuccessful bidders will be returned within **15 days** of awarding the Contract to successful bidder. EMD of the bidders not honouring their commitment / quotations may be forfeited at the discretion of the Regional Director for Telangana, Reserve Bank of India, Hyderabad, who is not bound to assign any reason for her action.

2. The successful bidder has to submit a Performance Bank Guarantee (PBG) of **Rs.35,00,000/- (Rupees Thirty-Five lakh only)** from a scheduled bank within a period of thirty days from the date of award of the Contract, in favour of the Reserve Bank of India, Hyderabad, valid for a period beyond six months of the validity. The EMD submitted along with the bid will be returned soon after receipt of the PBG. The format for PBG is given in **Form-II**.
3. The successful bidder will enter into a Contract Agreement with the Bank as per format in **Form-III**. The contract will be valid for a period of **one year** i.e., April 01, 2023 to March 31, 2024 and the uniform discount quoted by you shall remain firm and valid for the period.
4. Under no circumstance a request for alteration in the discount rate will be accepted/ considered.
5. Time is the essence of the contract, you have to make delivery of medicines at the Bank's specified dispensary as per the delivery schedule given in each Purchase Order. The chemists/ druggists /stockists must have their office at Hyderabad to execute the order and replace the rejected material if any, on priority.
6. It should be noted that liability to pay any duties, levies or taxes applicable, if any, under the law would be that of the chemists/druggists/stockists. The chemists/druggists/stockists will also have to bear all the expenses etc. connected with proper packaging, carting, transportation etc. in connection with supply to any place specified by the Bank. **The Bank will only pay the labelled MRP less discount allowed thereon as per your offer after deducting applicable GST TDS /applicable tax.**
7. Quotations (Bids) received without EMD would be considered as unresponsive and will summarily be rejected.
8. **Fall Clause:** If the chemists/druggists/stockists with whom the Bank has entered into a purchase contract offers a higher discount or sells or even offers to sell medicines following conditions of sale similar to those of the Bank's contract, to any person or organization during the currency of the rate contract, the discount rate applicable to the Bank will automatically be increased with effect from that date for all the subsequent supplies under the contract and the contract amended accordingly. Other parallel contract holders, if any, are also to be given opportunity to reduce their price as well, by notifying the reduced price to them and giving them 15 (fifteen) days' time to intimate their revised prices, if they so desire, in a sealed cover to be opened in public on the specified date and time and further action taken as per standard practice.
9. **Evaluation Criteria:** Quotations shall be based on discount to MRP and the contract for the period of one year i.e. from April 01, 2023 to March 31, 2024 (Form III) shall be given to the H1 bidder i.e. the bidder offering highest discount. The Bank may enter into parallel rate contracts with more than one chemists/druggists/stockists offering highest discount.

10. Fulfilling the above terms & conditions and offering the highest discount does not necessarily mean qualifying for the award of the Contract.

11. The Regional Director, Reserve Bank of India, Hyderabad reserves the right to accept any or reject any or all the offers received without assigning any reason thereof. The Regional Director, also reserves the right to relax or alter any clause mentioned in this document as seem appropriate to her in the interest of the Bank.

12. The Regional Director, Reserve Bank of India, Hyderabad, reserves the right to terminate the Contract at any point of time by giving one month notice period without assigning any reason and without prejudice to any other remedies available to the Bank.

SCOPE OF WORK AND TERMS & CONDITIONS

1 DELIVERY OF SUPPLIES

The delivery of supplies in full will be made within the time and place specified in the respective Purchase Order (PO).

2 NON-SUBSTITUTION / CONFIRMATION WITH SCHEDULE M

In case of indent for specific brand of medicines, the brand shall not be substituted. In all other cases, medicines confirming to schedule M specifications only shall be supplied.

3 PACKED SUPPLIES

Supplies are required to be made in original packing of manufacturer. The packing should approximately be nearest to the total quantity demanded of any particular medicine / drug in the PO.

4 AUTHORITY SLIP

In case an Authorized Official of the Bank or the Bank's Medical Consultant in charge of the Dispensary concerned gives any 'By Hand' Authority Slip to a beneficiary, the medicines will be supplied immediately to the beneficiary for a period as mentioned in the slip.

5 LIFE PERIOD OF MEDICINES SUPPLIED

Every medicine has its own shelf-life period mentioned on the label of medicine. The shelf life of medicines supplied should not have passed more than half of its shelf life at the time of supply.

6 The unused medicines if any, have to be replaced at least two months before the expiry date.

7 PRESENTATION OF BILLS

- (i) The GST invoices / bills should clearly indicate the details of the supplies made each day such as name of the item, name of manufacturer, batch no., date of manufacture & expiry, prescription slip no. with date, rate, discount as per contract etc. and any other information required by the Bank.
- (ii) The bill shall be supported by the original PO along with the certificate from the Bank's authorised official under his/her signature, with date, seal of the office for receipt of the items indented.
- (iii) Incomplete bills not accompanied by any of the particulars mentioned in (i) and (ii) above will not be entertained.

8 PERFORMANCE SECURITY

The amount of Performance Security shall be liable to be forfeited if the medicines supplied by the authorized chemists/druggists/stockists against the purchase orders placed on them in pursuance of this contract are subsequently found as having been stolen from anywhere or are not conforming to quality. The Performance Security is also liable to be forfeited if the authorized chemists/druggists/stockists:

- i) Fails to adhere to the terms of the Contract or
- ii) Supplies any sub-standard, spurious drugs or the substitute medicines.
- iii) Delays supplies.
- iv) Over charges

The chemists/druggists/stockists should not stop the supplies of the medicines/drugs without giving 30 days' notice.

9 DEDUCTIONS FOR DELAY/ DEFAULT

- i) In case of indent for specific brand of medicines, the same shall not be substituted. If any such case is noticed during subsequent scrutiny after or before the payment, then chemist/druggist/stockist will be penalized for Rs.1000 + cost of the specific brand of medicines for each such default.
- ii) The delivery of supplies in full will be made on the next working day by 10.30 a.m. or at the opening hours of Bank's dispensary, whichever is later, at the premises of the dispensaries to which indenting the supplies or in case of emergency at the residence of the patients as directed by the Bank. In the event of non-supply of indented medicines in time as aforesaid, Rs.500/- will be deducted from the bill of the chemist/druggist/stockist for each day or part thereof of delay in respect of each item.

10 TERMINATION FOR DEFAULT

The Bank may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the bidder terminate the Contract in whole or part:

- i) If the bidder fails to provide any or all of the services within the period(s) specified in the Contract
- ii) If the bidder fails to perform any other obligation(s) under the Contract.
- iii) If the bidder, in the judgment of the Bank has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

11 RESERVATION OF RIGHT FOR APPOINTMENT OF MORE CHEMISTS/DRUGGISTS/STOCKISTS

The Regional Director, Reserve Bank of India, Hyderabad, reserves the right to enter into annual contracts with any number of chemists/druggists/stockists. The Regional

Director, Reserve Bank of India, Hyderabad, also reserves the right to allocate, reallocate the dispensaries, existing and new ones that may be set up during the currency of the contract. The Regional Director, Reserve Bank of India, Hyderabad, also reserves the right to decide which supplier shall normally serve which dispensary. Without prejudice to the right, emergency purchases can be preferred from any of the empanelled supplier irrespective of such allotment of dispensary to each Authorized chemist/druggist/stockist for purchase of normal supplies.

12 SUPPLY OF MEDICINES

- i) Sufficient stock of standard quality of medicines at all times will have to be maintained by the chemist/druggist/stockist, to avoid inconvenience to the Bank's beneficiaries.
- ii) In case of failure or refusal on chemist's/druggist's/stockist's part to supply the medicines to the purchaser/ beneficiaries within the time as provided in the respective Purchase Order, the contract is liable to be terminated /cancelled at chemist's/druggist's/stockist's risk and cost. Any extra cost involved in arranging supply from alternative source will be recovered from the chemist/druggist/stockist. It is in addition and without prejudice to the deduction in clause 9 above and 12 (iv) below.
- iii) The chemist/druggist/stockist will indicate batch number, name of manufacturer, date of expiry in the indents at the time of supplying the medicines/drugs to the concerned Dispensaries.
- iv) The medicines/drugs to be supplied will be of standard quality. In case it is found that any particular medicine's date is expired or is near the date of expiry, found not of standard quality, substandard or spurious, chemist's/druggist's/stockist's (Appointed Authorized Chemist/Druggist/Stockist) firm will be liable to be debarred for a period of 3 years besides other legal action that may be initiated. In case the chemist/druggist/stockist fails to supply indented drugs/medicines, the Bank will be entitled to procure the same from other chemists/druggists/stockists and the chemist/druggist/stockist will be liable to reimburse in full the price paid by the Bank. However, the chemist/druggist/stockist will be allowed to claim what would be payable to him for the medicines as per the agreed terms and conditions.
- v) Indented medicines for the beneficiaries shall be supplied in individual packets by the designated chemist/druggist/stockist.

13 INDEMNITY

The bidder shall indemnify the Bank against all actions, suits, claims and demands brought or made against it in respect of anything done or committed to be done by the bidder in execution of or in connection with the work of this contract and against any loss or damage to the Bank in consequence to any action or suit being brought against the bidder for anything done or committed to be done in the execution of this contract. The bidder will abide by the job safety measures prevalent in India and will free the Bank from all demands or responsibilities arising from accidents or loss of life, the cause of which is the bidder's negligence. The bidder will pay all indemnities arising from such incidents without any extra cost to Bank and will not hold the Bank responsible or obligated. The Bank may at its discretion and entirely at the cost of the bidder defend such suit, either jointly with the bidder or single in case the latter chooses not to defend the case.

14 PAYMENT

The authorized chemist/druggist/stockist shall claim payments twice a month. Payments of the bills presented will normally be arranged in 10 working days from the date of presentation of the bill. However, the authorized chemist shall make no claim from the Bank in respect of interest or damages in case the payment is delayed for any reasons. The payment has to be through NEFT for which bidder should give requisite details of bank address, Account no. etc.

15 ARBITRATION

The Contract is based on mutual trust and confidence. Both the parties agree to carry out the assignment in good faith. If any dispute or difference of any kind whatsoever (the decision whereof is not herein otherwise provided for) shall arise between the Bank and the Bidder in connection with or arising out of the Contract, whether during the contract period or completion and whether before or after the termination, abandonment or breach of the contract, shall be referred to and settled by sole arbitrator, the Chief General Manager, Human Resources Development Department, Central Office, Reserve Bank of India, Mumbai who shall give written award of his decision to the Bidder. The decision of the Chief General Manager will be final and binding.

AND WHEREAS it is one of the terms of the tender document that the successful bidder has to submit a performance bank guarantee by a scheduled bank for entering into a contract.

AND WHEREAS it has been stipulated by you in the said contract that the successful bidder shall furnish you with a bank guarantee by a scheduled bank for the sum specified therein as security for the compliance with the successful bidder's performance obligations in accordance with the contract.

AND WHEREAS we have agreed to give guarantee for the successful bidder.

THEREFORE WE hereby affirm that we are guarantors and responsible to you up to a total sum of Rs.35,00,000/- (Rupees Thirty Five Lakh only) and we undertake to pay you, upon your first written demand declaring the successful bidder to be in default under the contract and without demur cavil or argument, any sum or sums within the amount as aforesaid, without your needing to prove or to show the grounds or reasons for your demand or the sum specified therein.

2. A letter from your office that the successful bidder has committed default in the due and faithful performance of all or any of its obligations under and in accordance with the contract shall be conclusive, final and binding on us. We further agree that you shall be the sole judge as to whether the successful bidder is in default in due and faithful performance of its obligations under the contract and your decision that he is in default shall be final and binding on us notwithstanding any differences between you and successful bidder or any disputes between you and him pending before an Arbitrator or any other court or tribunal or authority.

3. In order to give effect to this guarantee you shall be entitled to act as if we are the principal debtor and any change in our constitution or that of successful bidder shall not, in any way, or manner affect our liability or obligation under this guarantee.

4. You shall have liberty, without affecting in any manner our liability under this guarantee, to vary at any time, the terms and conditions of the contract or to extend the time or period for compliance or to postpone for any time the exercise of any of your rights or enforce or forebear from enforcing any of the terms and conditions of the contract and we shall not be released from our liability or obligation under this guarantee by any exercise of such liberty by you or other forbearance, indulgence, act or omission on your part.

5. We undertake not to revoke this guarantee during its currency.

6. Any notice by way of request, demand or otherwise hereunder may be sent by post addressed to us at above referred branch, which shall be deemed to have been duly authorized to receive such notice and to effect payment thereof forthwith, and if sent by post it shall be deemed to have been given at the time when it ought to have been delivered in due course of post and in proving such notice, when given by post, it shall be sufficient to prove that the envelope containing the notice was posted and a certificate signed by any of your officers that the envelope was so posted shall be conclusive.

7. This guarantee shall come into force with immediate effect and shall remain in force and effect for a period of one and a half year or until it is released by you pursuant to the provisions of the contract.

1. In this agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this agreement, viz.:

2.1 the Request for Empanelment document dated _____ submitted by the Supplier;

2.2 the Request for Quotation document submitted by the Supplier & terms and conditions of the bid

2.3 the Purchaser’s Notification of Award

3. In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the contract.

4. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the contract price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.

5. Particulars of the goods and services which shall be supplied / provided by the Supplier are as enlisted in tender document condition.
